Minutes of Wheldrake Parish Council Meeting held at 7pm in the Village Hall on Wednesday 27th February 2019

Part 1:

18225: Welcome:

The Chair welcomed all Cllrs, Clerk and public to the meeting

18226: Apologies/Attendance:

a. Attendees:

Cllrs Mercer, Arnold, Jordan, Surtees, Southern, Bell, Myers, Nelson, Urwin, three members of the public, a PCSO and the Clerk.

18228: Minutes:

a. All members accepted the minutes from the previous meeting held on Wednesday 30th January 2019.

b. Approval was granted and the Chair signed the minutes as a true record.

18229: Council:

The Council received no comments on agenda items.

One elector present raised the issue of the 2019/20 budgeted figure for the Clerk. This is a budget figure and therefore not a target. This figure cannot be directly compared to other parishes.

18231: Reports:

a. Ward Councillor

The Ward Councillor mentioned the planned roadworks taking place on Broad Highway and clarified that this does not affect the whole road, just a section. The works are planned to take up to 3 weeks however this could be less. Advanced warning was given to all residents affected.

b. Police

PCSO Thompson was present at the meeting and was able to say that in January there were no incidents reported in the village. During February she mentioned that there was a vehicle driven on some land affecting property. No other reports.

One Cllr raised the question of vehicles adhering to the speed limits within the village and the Council has been advised how to deal with and report this issue. She also advised how to proceed with the possibility of the village looking into a mobile speed radar visiting. Further details regarding this will be discussed at future meeting.
